Scope of Work

BACKGROUND

U.S. Embassy Nairobi is looking for a reputable firm to offer its services in media monitoring. This will involve capacity to produce a daily product summary of media reporting in Kenya including English, swahili and vernacular languages in print, radio, television, and online news as well as trending topics on social media and monitoring of key social media accounts.

Overview

The contractor will be required to track all news media outlets (print, electronic, online) and provide online links to content that will help the US mission in Nairobi understand which outlets give coverage of U.S government activities in Kenya, activities that generate coverage and the tone used in reporting. The contractor will provide a daily wrap up that curates news commentaries, and resources related to the U.S government with a focus in national publications, radio and television broadcasting stations in Kenya and online news channels including social media.

I. PERFORMANCE WORK STATEMENT

A. The purpose of this firm fixed price contract is to provide media monitoring services per the following specifications.

1.0 Objectives

This media monitoring support will assist U.S. Embassy Nairobi public affairs office in:

- tracking and assessing media coverage of U.S. government-related activities and investments
- measuring the effectiveness of communications, public information and outreach efforts from the U.S Embassy Nairobi
- monitoring issues of strategic importance to the United States.
- accessing timely, relevant data to inform high-level decision-making.

2.0 General Scope

1. The contractor will be required to set-up a media monitoring system to meet stated objectives.
2. The contractor will advise on appropriate methodologies and parameters that may be essential to achieving overall media monitoring objectives.
3. The contractor will be required to provide daily tracking and clippings of newspaper articles, TV shows/broadcasts, radio shows/broadcasts and online news articles on websites based on agreed upon combinations of keywords and phrases. Tracking should include news, as well as opinion, advertorial and editorial coverage.

3.0 Task

The contractor shall provide media monitoring of U.S government investments associated with the Kenya mission based on a combination of keywords that will be provided by the embassy's public affairs team to the winning firm. Monitoring must capture content using the same combination of keywords in national newspaper publications, TV shows/broadcasts and radio shows/broadcasts in Kenya.

- Coverage must include all national newspaper publications, TV shows/broadcasts, radio shows/broadcasts in Kenya including vernacular radio.
- Coverage must include news searches from web-based media platforms in the daily media monitoring report sent to the US embassy. This includes local dailies that have online platforms.
- Regional or county coverage is preferred. English, Kiswahili and vernacular languages are required and should be representative of populations in all major regions.
- Offeror must include a list of national, and county based electronic and print media outlets (licensed, community or vernacular radio stations, television stations, newspapers and periodic magazines) that will be tracked across the country in the technical proposal.
- The offeror shall convene a strategy meeting/s with the embassy's public affairs team to take them through an overview of the organization's operations and the technical approach to the media monitoring process against the deliverables set. This includes a deeper discussion into topics such as effective keyword development, tonality/sentiment, monthly/quarterly/annual reports.

4.0 Key deliverables

1. The contractor will deliver one daily report with links to search results and relevant information such as headline, publishing date/time, journalist, keyword referenced, relevant summary, media house and tonality. Daily reporting should be delivered in a

tailored format that makes the information easy to manage and share across multiple stakeholders. The report should be sent to the public affairs team daily in the morning preferably at 6 am before our official working hours. Contractor must include a sample daily report with the technical submission.

2. The contractor will provide access to a central database where all clips and results can be stored and accessed by the U.S embassy. The database should allow for exporting reports and related analyses based on customized searches by date, media house/publication/channel, country and end-user categories/tags.
3. The contractor will provide a daily and weekly report on key trends on the social media landscape in Kenya, number of mentions, audience impressions/reach on our social media accounts from the content pushed out, and analysis of messaging coming out of key social media accounts monitored. Social media monitoring will include online periodicals, blogs as well as key social media channels such as twitter and Facebook. The contractor will convene a strategy workshop to give opportunity for broader discussion on the technical approach towards the social media monitoring process and provide relevance to the need for its services.
4. The contractor will develop quarterly reports and presentations, as well as end-of-year project reports and presentations based on the client's needs. Reports can include a detailed analysis on coverage including number of mentions, audience impressions/reach, demographics of those reached (preferred, not required), advertising value, sentiment (tone), prominence and advertising value. The reports should include strategic analysis and insights on key trends, topics and opportunities to maximize media coverage such as expert recommendations that can influence press coverage in Kenya. Insights could include identifying key journalists and media houses, examining current events within the media, contextual information or other. All reports must be written for a non-media audience, be easy-to-read and formatted with clear visuals such as charts and graphs.

5.0 Reporting Requirements

i. News Monitoring (Electronic and Print, online news channels)- Daily Reports.

One daily report with links to search results and relevant information. The vendor is required to provide daily tracking and clipping of newspaper articles, TV shows/broadcasts, radio shows/broadcasts and websites based on agreed upon combination of keywords and phrases. Tracking includes news, as well as opinion, advertorial and editorial coverage.

ii. Social Media Monitoring.

Daily report on key trends on the social media landscape in Kenya. Monitoring to include online periodicals, blogs as well as key social media channels such as twitter and face book.

iii. Weekly Reports.

Weekly report which gives an expert analysis and insights on trending conversations arising from reported news. Strategic analysis on coverage of US Government activities and opportunities to maximize media coverage in Kenya. The report should include an analysis of coverage of US Government activities in Kenya which includes but not limited to U.S. Embassy Nairobi initiative activities and events, and activities of agencies within US mission in Kenya (CDC, PEPFAR, USAID).

Weekly report analyzing the key trending topics in social media and the impression they generate shaping conversation in the public online sphere. The report should include an analysis of number of mentions, audience impressions/reach on our social media accounts from the content pushed out, and analysis of messaging coming out of our key social media accounts.

iv. Portal Access 24/7/365

Access to a central database where all clips and results can be stored and accessed by the U.S. Embassy.

v. Quarterly Reports

Quarterly reports with detailed analysis on media coverage of U.S. government-related activities and investments including number of mentions, audience impressions/reach, demographics of those reached (preferred, not required), sentiment (tone), prominence and advertising value.

vi. Annual Reports

Annual report with summary analysis of media coverage of U.S. government-related activities and investments measurement of the effectiveness of communications, public information and outreach efforts from the U.S Embassy Nairobi. The report should include expert recommendations that can influence press coverage U.S. Embassy Nairobi activities in Kenya.

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. **For questions relating to the interpretation of the IRS regulations go to <https://www.irs.gov/help/tax-law-questions>.**
